I think you have identified well that of all of the numerical data points that your app could search, food nutrition is the one that would be used most often and have the broadest reach. Where the business plan gives me pause is when you say it will take 2-3 years to develop the product and then another 6-18 months to get it to market, for a potential total of 2.5 - 4.5 years. This is a concern because of the various juggernauts who are your competitors and who are constantly working to improve their search engines, Google and Microsoft in particular, Also, while I understand the gap in technology, I'm not convinced that it would make a significant enough difference to the end user that it would create demand. There is so much content out there already that lists the "Top Ten Most Fibrous Beans" or the "Foods with the highest protein on the Keto diet" I think there is a good chance this need is already being met. I would encourage you to figure out a way to move faster and then, too, to make sure you get it protected and think about shifting your focus to have a search engine (Google, Microsoft, etc.) acquire your technology. To me that's the play, because they would have the resources and experience to know how to best deploy your technology on a broader scale.
